The Status Code of Fire Violations and Penalties Application has been Amended May 6, 2022 by Ordinance No. 2022-09.

The fee for issuance of a Status of Fire code Violations and Penalties Report shall be \$25.00 per report.

The request shall be made at least two weeks prior to closing.

Should the Status of Fire Code Violations and Penalties report not be obtained prior to the sale of the property, a fine of \$50.00 will be imposed in addition to the cost of the report.

All Commercial, Hi Rise, Life Hazards, Multi Units, Multi Use, Tri Plex buildings shall apply.

This does not apply to Single Family as well as Duplexes, which are under the Building Departments jurisdiction.
